ANNUAL MAINTENANCE CONTRACT

This document outlines the TERMS & CONDITIONS under which AMC for A-CUBE VOICE LOGGERS / PHONE RECORDERS are accepted. This Document may also be termed as the AMC CLAUSE

- 1. Products, which do not fall within the scope of Warranty, can be covered under the AMC Scheme.
- 2. Each Genuine A-CUBE Product carries with a Hologram with the Product Serial No. mentioned on it. Neither the Product, nor the hologram should be tampered with in any manner. This will render the AMC null and void.
- 3. The AMC is restricted to the Voice Logger / Phone Recorder unit only. The Connecting Cables and Software CD are not covered under AMC
- 4. The AMC is accepted subject to the condition that the Product will be used (a) solely for the purpose for which it has been designed. (b) The Conditions for and the use of the product will be normal and proper. © The Product will not be subjected to improper use and / or conditions
- 5. The product will be provided Clean and Proper Power Supply. There will be no improper / over Voltage / Earthling / Leakage of Power to the Product from the Power Line / Computer / Telephone Lines / EPABX So as to Short Circuit the product leading to its Brown out or Burn Out. Products, which suffer Brown Out or Burn Out, are not covered under AMC. Vendor decision on Burn out or Brown out of the product will be accepted as final and binding
- 6. Physical damage to products due to accident or natural calamities is Not covered under AMC
- 7. Defective Products are to be returned to us in safe, and secure packing. We will dispatch the Repaired / Replaced product within 4-5 working days of receipt at our end. The decision to repair or replace the product will belong to the Vendor. The Vendors responsibility is restricted only to returning a working product. One way Freight will be borne by either party.
- 8. The Vendors responsibility is restricted only to the maintenance of the product under AMC. Vendor cannot be held responsible for any loss of data or commercial advantage due to the product having turned defective.
- 9. Award of AMC Contract implies that the customer has read, understood and accepted this AMC Clause
